

TERMS AND CONDITIONS

For your benefit and ours, please ensure that the entrance gate has closed after entering and departing the property.

We appreciate your co-operation with the following Arrival and Departure times, unless prior arrangement:

Check In: From 14.00 - 19.00pm

Check Out: Before 11.00 am

Delayed departures must be arranged with the prior approval of management beforehand to ensure availability.

When making your travel arrangements it is your responsibility to ensure you arrive on the correct day and time. Late check-in's and late departure's will be charged at a rate of R60.00 an hour and only with prior arrangements.

It is your responsibility to take out appropriate personal travel insurance.

Vehicles are parked at the owners own risk.

Please note that unregistered/non-paying guests are not allowed onto the premises.

The test will be conducted by management and it is therefore that I ensure that entry and exit times are kept reasonable and that I will inform my host when arriving in advance. Daily records shall be kept by management and the results kept on file for the entire length of COVID -19 shutdown. • Any indication of temperature reading concerns (ie over 38o C) will restrict access the premises until cleared by a Medical practitioner in writing. I am aware that I will be required to wear a face mask(in public).
